Preamble

In the following hygiene concept strategies will be described to avoid the spreading of the COVID 19 virus during the eventing competition, which is held in Stroehen, Germany, from 1st till 3rd of October under FEI and FN governance and is organized by the Reit- und Fahrverein Ströhen at Tierpark Ströhen/ Ismer Stud. Protection of athletes, grooms, other staff and members of the organizing committees is the first aim.

The current infectious situation in Germany is on a stable medium level (appr. 80/100.000 per 7 days), but allows sport events under certain regulations which are described by the government of Lower Saxony.

1. Personal rules and behaviour

Every person at the showground is responsible for the following behaviors:

- Check-in and personal data: Please provide the organizer with the following personal data in order to follow up on any person, if an outbreak of Covid 19 has been recognised:
 - o Name, Address, Telephone, email, time of entry, time of leaving.
 - o You can either check in by LUCA APP or fill out a registration form at the show office.
- Keep distance to any other person of minimum 1,5 m at any time if possible.
- If keeping the distance of 1,5 m is not possible, please wear a face mask (surgery standard or FFP 2).
- Please wash your hands regularly and use disinfectants to avoid manual virus spreading.
- In case of fever or uncomfortable feeling please contact the show office or the show medical officer.
- Please check your body temperature daily.
- If you feel sick, please do not enter the event or immediately put yourself in quarantine.

2. General measures

- Every athlete and officials will be provided with a paper with the following contents:
 - a) explaining the general rules and behaviour
 - b) contact information of medical officers and show office
 - c) location map with general and sanitary informations
 - d) behaviour in case of a suspicion of a COVID 19 infection

- Show officials and athletes and grooms will be informed during the meetings and briefings about the general rules and behaviours to avoid infections with COVID 19.
- Members of the show team will be instructed for contact protection measures at the show office and any other critical situations
- All food and beverage will be only for take away and outdoor. A queue management will be provided, wherever necessary.
- Toilets and showers will be cleaned and disinfected regularly.
- Handsanitizers will be provided at the entire showground.
- The show organizer will take care that every attendand is registered by Luca App or by written form.
- The show organizer will contact the local health organization and administratives to coordinate the COVID 19 measures at the show and possible consequences in case of an outbreak at the showground.
- The show organizer will determine a hygiene officer, who is responsible for coordination and supervision of the hygiene measures.
- The show organizer will organize a permanent medical staff at the showground to be able to handle an outbreak scenario.
